Tender documents will be available from **10h00 on Thursday, 3 October 2019**, during working hours at the cashier office, uThukela District Municipality, 36 Lyell Street, Ladysmith at a non-refundable cost of **R600.00** per document. Documents will also be available on-site inspection.

**Tenderers should have a CIDB Contractor Grading as specified in the table above, or higher. Tenderers must score a minimum 70 points on Functionality for the tender to be considered further.**

A **compulsory** Site Inspection will be held on site on **Thursday, 10 October 2019 at 10h00**. Failure to obtain a Tender document or non-attendance at the site inspection will result in the immediate disqualification of your tender. Tenderers are required to meet at uThukela District Municipality, 36 Lyell Street, Ladysmith from where tenderers will travel in convoy to site close to Weenen (approximately 60km from Ladysmith).

Sealed tenders endorsed with the **Tender no. and Discription of the Tender** must be deposited in the tender box of the uThukela District Municipality, 36 Lyell Street, Ladysmith before **12h00 on Thursday, 7 November 2019**, after which tender will be open in public.

It will be the tenderer's responsibility to check the document on receipt for completeness and to notify the employer of any discrepancies or omissions. It is the tenderer's responsibility to provide all the data and information requested completely and in the form required, failure to do so may be regarded by the employer as a non-responsive tender.

A minimum of 30% of the value of the contract must be contracted to:

- An EME or QSE
- EME or QSE which is at least 51% black owned,
- EME or QSE which is at least 51% owned by black youth (from the ages 14 to 35),
- EME or QSE which is at least 51% owned by black people who are women,
- EME or QSE which is at least 51% owned by black people with disabilities,
- EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships,
- A co-operative which is at least 51% owned by black people,
- EME or QSE which is at least 51% owned by black people who are military veterans; or

More than one of the categories above
