Tenderers are required to meet at uThukela District Municipality, 36 Lyell Street, Ladysmith from where tenderers will travel in convoy to site at George Cross Water Treatment Works in Estcourt.

Sealed tenders endorsed with the **Tender no. and Discription of the Tender** must be deposited in the tender box of the uThukela District Municipality, 36 Lyell Street, Ladysmith before **12h00 on Thursday 26 July 2018**, after which tender will be open in public.

It will be the tenderer's responsibility to check the document on receipt for completeness and to notify the employer of any discrepancies or omissions. It is the tenderer's responsibility to provide all the data and information requested completely and in the form required, failure to do so may be regarded by the employer as a non-responsive tender.

A minimum of 10% of the value of the contract must be contracted to:
