## INVITATION TO TENDER

### UPGRADE OF LANGKLOOF PACKAGE PLANT & SUPPLY

#### DWS REGIONAL BULK INFRASTRUCTURE GRANT FUNDING

## CONTRACT NO.35/2022-CON

Tenders are invited from competent and suitably experienced contractors for the upgrade of Langkloof Package Plant and construction of the Bulk Water Supplies which caters for reticulating of potable water within the targeted settlement of Langkloof. This contract is an upgrade of existing scheme components comprising 1No. Pump-station, 1No. Submerged Pump, pumping Main to the 200KI storage reservoir and the existing reticulation network pipelines which terminates to the communal standpipes.

The scope of works for this contract comprises the construction of approximately 350 meter long x 100mm diameter steel pipeline supported by Concrete Pillars or Plints, Safely removal of the existing 0.4Ml/day package plant, supply and erect a new 1.5Ml/day package plant. The construction of the newly proposed rising / pumping main to connect to the newly proposed one (1.0) Mega Litre reinforced concrete reservoir. Construction of newly proposed suitably sized gravity main with the reticulation pipe network that provides yard connections. Supply and install water meter and provision of the yard standpipes to all households within the project foot print. Supply and install telemetry / SCADA systems and supply and erect of fencing for the package plant and reservoir sites.

The employer for this contract is the UThukela District Municipality. The objective of the Employer is to employ the principles of Labour Intensive Construction Methods as set out in the EPWP Guidelines. The UThukela District Municipality subscribes to the Preferential Procurement Policy Framework Act 2011 (Act No.5 of 2011) and it's Preferential Procurement Regulations, revised 2011. In terms of Regulation 6, the 90/10 preference point system will be applicable, with 90 points for Price and 10 Points for B-BBEE Status Level of Contribution.

Only tenderers who are registered with the CIDB in a contractor grading **8CE** or higher and have extensive experience in the construction water reticulation networks and water retaining structures will be eligible for award. The employer intends making a meaningful contribution to the economy within the UThukela District by championing the engagement of local district subcontractors at a 30% Contract Participation Goal (CPG). The uThukela District Municipality will present a list of District contractors registered with the CIDB in a contractor grading of at least 4CE with a view of being involved from contract inception to contract completion. The list will be presented to the successful Tenderer.

In terms of the Tender Data, only responsive tenders scoring in excess of 75 points on the evaluation criteria will be considered for further adjudication.

Documents may be collected from the UThukela District Municipality, 36 Lyell Street, Ladysmith, KZN during working hours as from **Wednesday, 28<sup>th</sup> September 2022 to Monday, 03 October 2022**. A non-refundable deposit of **R 800**, payable in cash, is required on collection of the tender documents.

A compulsory Site Inspection meeting with the Employer's Agent will take place on **Tuesday, 11 October 2022 at 11h00**. Prospective Tenderers shall meet at the Contract site office (referred to as the Langkloof Water Works) in Langkloof. **Directions to the venue from Pietermaritzburg side: Take exit 194 from N3. Proceed on R74 through Bergville town for a distance of approximately 72 km, then turn left and then drive about 1.5 km to your destination on your right (co-ordinate : 28°38'01.65 S – 29°05'13.63 E).**

The Employer's Agent shall not be available for inspection purposes on any other occasion. Failure to attend the site inspection will result in immediate tender disqualification.

Sealed tenders endorsed **"TENDER NO. 35/2022-CON: "UPGRADE OF LANGKLOOF PACKAGE AND BULK SUPPLY WITHIN WARD 10"**, must be deposited in the tender box of the UThukela District Municipality, 36 Lyell Street, Ladysmith before **12h00 noon, Thursday, 27<sup>th</sup> October 2022**, after which tenders will be open in public. UThukela District Municipality does not bind itself to accept the lowest or any of the tenders and reserves the right to accept the whole or any part of the tenders.

Local Production and Content is required to some items as per designated sectors from Department of Trade and Industry designated sectors will be attached on the tender document.

If the service provider is currently rendering services to the municipality with a stage of completion less than 50% during the adjudication stage will not be awarded another project for mitigation purpose.


