- "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised 2.4 competitive bidding processes or proposals;
- "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic 2.5 Empowerment Act, 2003 (Act No. 53 of 2003);
- "comparative price" means the price after the factors of a non-firm price and all unconditional 2.6 discounts that can be utilized have been taken into consideration;
- "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract; 2.7
- "contract" means the agreement that results from the acceptance of a bid by an organ of state; 2.8
- "EME" means any enterprise with an annual total revenue of R5 million or less. 2.9

- In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE. 3.4
- However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must 3.5 be the one scoring the highest score for functionality.
- Should two or more bids be equal in all respects, the award shall be decided by the 3.6 drawing of lots.
