uThukela District Municipality subscribes to the Preferential Procurement Regulations, 2022 (the 2022 Regulations) in terms of the Preferential Procurement Policy Framework Act 5 of 2000 (the PPPFA). In terms of Regulation 6, the 80/20 preference point system will be applicable, with 80 points for Price and 20 Points for Specific Goals as per the table below.

Only bidders who are registered with National Treasury Central Supplier Database (CSD) will be eligible to bid.

- A Performance Guarantee of 10% of the Contract Value will be required on this contract;
